
From Wallan-Whittlesea Road, turn into Clarkes Road, this turns into Glenburnie Road, TR into 12th Ave, then 2nd right into 17th Ave.
When in 17th Ave, go to the top of the hill, and the gate is on the LHS – signs will be out.

If you are camping overnight, you must be self sufficient with food and water for you and your horse.



SPECIAL RESOLUTION - AMENDMENTS TO INCORPORATION ACT & AMENDMENTS TO

GDTRC CONSTITUTION

SUMMARY OF AMENDMENTS TO INCORPORATION ACT

On 26 November 2012, the *Associations Incorporation Act 1981* was replaced with the *Associations Incorporation Reform Act 2012* (and its associated regulations). The new Act includes 'transitional arrangements' to help associations adjust to the new laws. These are outlined below:

What are the changes to the Associations Incorporation Act? The main changes by the Bill are:

- **Public Officer**

The role of the 'Public Officer' and the 'Secretary' are merged, and replace simply with 'Secretary'.

- **Status of the Incorporated Association**

Any association incorporated under the old Act remains so under the new Act. The incorporation date is not affected and the certificate of incorporation remains valid.

- **Statement of Purpose**

Under the new Act the association's statement of purpose will automatically be deemed part of its rules.

If the association applies to change its rules after new legislation starts, its statement of purpose must be included in its proposed new rules.

- **Rules**

Schedule 1 of the new Act contains new items that an association's rules must address. These are:

- An association's name & Purposes
- Members' rights and obligations
- Procedures for resignation and cessation of membership
- The process for appointment and termination of the secretary
- Preparing and keeping of minutes of general and committee meetings
- Enabling members to access minutes of general meetings, including financial statements submitted at a general meeting
- Right of members' access (if any is specified in the rules) to committee meeting minutes.

- **Financial Statements**

The new Act introduced a three-tiered reporting structure. An association will be classed as tier one, two or three, depending on its revenue. For example:

- Tier One: less than \$250,000
- Tier Two: \$250,000 - \$100,000
- Tier Three: more than \$1,000,000

This new structure will replace the current 'prescribed' and 'non-prescribed' reporting structure.

Incorporated associations must understand the new structure and work out which tier they come under, as this will affect their reporting obligations. Visit consumer.vic.gov.au association for details.

- **Meeting Minutes**

The rules of an incorporated association will now be required to cover a number of new matters in relation to the keeping of, and access to, minutes of meetings. All incorporated associations will need to have rules which:

- Require that accurate minutes of all general and committee meetings must be prepared and kept;
- Provide members with access to the minutes of the general meetings of incorporated association (including accounting records and financial statements);

And

- Clarify whether or not members can have access to the minutes of meetings of the Committee of management of the incorporated association (and, if so, the terms and conditions on which such minutes are to be made available).

- **Requirement of return of documents of an incorporated association**

All office-holders, former office-holders or members of an incorporated association are now required to return any documents belonging to an incorporated association within 28 days if they cease to hold office or be members of the organisation. A failure to return documents within 28 days timeframe allows the association to apply to the Magistrates' Court to ensure performance.

- **Special Resolutions**

A notice of a proposed special resolution will have to set out the full details of the proposed special resolution and must be provided to members at least 21 days in advance. The notice will also have to make it clear that the resolution is being proposed as a special resolution. This amendment is now in force.

- **Documents provided to Registrar**

The Registrar of Incorporated Associations at Consumer Affairs Victoria ('the Registrar') now has the power to refuse to receive any document submitted by an Incorporated Association if the Registrar believes the document is not a valid document of the incorporated association. The Registrar can make inquiries to determine whether a document is legally valid. Also, if an incorporated association submits a special resolution for alteration of its rules to the Registrar (under the section 22 of the Act), the Registrar now has the power to accept some but not all, of the proposed alterations. These amendments are now in force.

- **Statutory Management**

The Registrar can investigate the affairs of an Incorporated Association, including its functioning and financial condition. Where, following such an investigation, the Registrar considers it in the interests of the Incorporated Association's members, creditors or the public, the Registrar can apply to the Victorian Magistrates' Court for the appointment of a 'statutory manager' to conduct the affairs of an incorporated association.

If a statutory manager is appointed, all members of the committee of management (or governing body) of the incorporated association will immediately cease to hold office. A statutory manager will have a range of powers to deal with the affairs of the incorporated association. These amendments are now in force.

- **Magistrates' Court actions**

There are a number of new actions that can be taken to the Magistrates' Court of Victoria in relation to incorporated associations, including:

- The Registrar can apply to the Magistrates' Court for an order restraining the incorporated association from doing an act that is outside the association's statement of purposes, if the Registrar is satisfied it is in the 'public interest' to do so;

- A member (or, in more limited cases, a former member) of an incorporated association can apply directly to the Magistrates' Court for an order preventing an incorporated association from engaging in oppressive conduct. 'Oppressive Conduct' is defined as conduct that is unfairly prejudicial to, or unfairly discriminatory against, a member of an incorporated association or is contrary to the interests of the members of the incorporated association as a whole.

The Victorian Magistrates' Court now has a new power to refer matters involving incorporated associations, which raise certain questions of law, to the Victorian Supreme Court for determination. These amendments are now in force.

- **Voluntary Cancellation of Registration and Voluntary Administration**

Small incorporated associations which have less than \$10,000 assets (and meet other requirements) will now be allowed to apply to the Registrar for voluntary cancellation of the registration of the association.

The voluntary administration provisions of the Commonwealth Corporations Act 2001 (Cth) will now apply to Victorian incorporated associations. These amendments are now in force.

- **Auditor Removal**

An auditor of an incorporated association can now be removed from office by a resolution of members at a general meeting. Notice of the proposed resolution must be given to members at least 2 months in advance of the meeting and copies must be provided to both the auditor and the Registrar as soon as possible. This amendment is now in force.

- **Surplus Assets on Winding Up**

A new provision now prevents the surplus assets of an incorporated association from being distributed to members on voluntary winding up, unless the 'member' is a body corporate (like an association or a trust) which itself cannot distribute assets to its members.

If existing incorporated associations currently has a rule which permits distribution to

members on voluntary winding up, this rule will continue to be valid so long as it was made before 7 April 2009.

- **Other**

There are also a number of minor and consequential changes to existing provisions in the Act.

SPECIAL RESOLUTION TO AMEND GDTRC CONSTITUTION

To consider and, if thought fit, pass the following resolutions as a special resolution.

Note: A special resolution is passed if it is approved by not less than three quarters of the members voting either in person or by proxy.

Clause 5 (2) **Junior Members** shall be any persons of a minimum age of eight (8) years but under the age of eighteen (18) years participating in riding activities or events conducted by the Association on payment of the subscription or such other sum as may nominate time to time be declared upon the Association at any General Meeting

COMMITTEE DUTIES & RESPONSIBILITIES

Committee positions are listed below. Further information regarding the duties and responsibilities of committee members may be obtained by contacting any of the current position holders.

President: Chair Committee meetings, assist with preparing meeting agendas, liaise with the workers, participate in management decisions, delegate tasks.

Vice President: Attend Committee meetings, stand in as President in President's absence, participate in management decisions.

Secretary: Attend committee meetings, record minutes of Committee meetings, assist with preparing meeting agendas, participate in management decisions and reporting requirements to CAV & other agencies as required.

Treasurer: Attend Committee meetings, keep records of all monies received and expended, ensure payment of workers' salary, taxation, Work cover and payment of accounts, prepare annual budget and financial statements, submit books to the Auditor prior to Annual General Meeting, participate in management decisions.

General Members:

Attend Committee meetings, contribute to and participate in management decisions, carry out any tasks delegated by Committee.

GREAT DIVIDE TRAIL HORSE RIDING CLUB

Club Rules

- NO STALLIONS allowed on rides at any time.
- Horses are to be reasonably fit, with feet adequately conditioned and / or shod.
- Breastplates and cruppers are recommended.
- Riders under 18yrs of age are required to wear an approved riding helmet.
- Riders under 16yrs must be under supervision of an adult.
- Horses known to kick must wear a red ribbon in their tail / or supplied stickers on their rump.
- Dogs are not permitted on the rides and must be kept securely on a lead around the float parking area.
- Drinking alcohol whilst mounted is strictly forbidden.
- ALL RIDERS must adhere to the GDTR rules which incorporate the ATHRA Code of Conduct.
- Permission must be obtained to ride in front of the Trail Boss or behind the Drag Boss.
- The trail must not be left without permission of a ride official at any time.
- Keep left to the roads.
- The trail must not be littered (this includes cigarette butts.) What you take with you must be brought back with you.
- GDTR recommends that ALL riders have current Ambulance cover.
- All riders must be mindful of other riders at all times.
- All gates must be left as they are found. Keep to the tracks as defined. Respect private property.
- All members are expected to abide by the club constitution, which is available on request.
